## Instructions for Completing the Mission Support Intention Form



Dear Partners in Stewardship,

The form on the reverse side of this page indicates your synodical and churchwide Mission Support intention for 2008. In determining what God is calling your congregation to contribute to the ministries of the larger church, you are invited to use a process that emphasizes proportional giving. This expresses congregational benevolence as an ongoing and growing percentage of regular giving; that is, your congregation's anticipated income.

Prayerfully consider this process when completing the form:

1) Determine your mission support figures for 2007:

What is your anticipated income for 2007 (please include all resources you typically use to build your budget)? \$ \_\_\_\_\_

What is your mission support commitment for 2007? \$ \_\_\_\_\_

What is your mission support percentage? \_\_\_\_\_ %

You will find the percent of your Mission Support by dividing the budgeted figure for Mission Support by the figure for anticipated income.

*Example:*    *Anticipated income* \$130,000.00  
                  *Mission support*     \$ 13,000.00  
                   $\$13,000 \div \$130,000 = 0.10$  or 10%

2) Calculate your mission support intention for 2008:

What is your anticipated income for 2008? \$ \_\_\_\_\_

What portion of your income will you designate for mission support through the synod and ELCA? \$ \_\_\_\_\_

In response to Christ's gracious love, prayerfully consider growing your contribution to the work of the whole church by an additional 1% of anticipated income. \_\_\_\_\_ %

What will be your mission support commitment for 2008?

You will find this amount by multiplying the your anticipated income by the percent designated for mission support. \$ \_\_\_\_\_

*Example:*    *Anticipated income* \$140,000.00  
                  *Portion designated*            11%  
                  *Mission support*     \$ 15,400.00
